WP3 Database development

Responsible Partner – ERDF PP9 – SNC SR

- Identification of spatial data requirements and assessment of existing national and transnational data sets.
- Harmonisation of monitoring and data collection methods.
- Collection of data on species and habitats in the Carpathians and their distribution.
- Analysis of the collected data





WP3 Database development

- Identification of most endangered habitats and species, and of invasive alien species.
- Further development and establishment of a Carpathian Red List of Species and Habitats and of a list of invasive alien species.
- For information sharing a web-based data catalogue will be set up.





WP3 Database development

- Inclusion of the collected data in the Carpathian Protected Areas Clearing House Mechanism (CPACHM) – basis for the Carpathian Joint Biodiversity Information System (CJBIS).
- Establishment of the geo web referenced interactive CJBIS that will further develop the CPACHM.
- Explanation of the use of the CJBIS to PAs managers and other stakeholders through the organisation of the Carpathian Protected Areas Conference.
- Organization of WP meetings.

Questions and themes for discussion



- Because of the time and funds restrictions, only first draft of the red lists of selected groups can be prepared – only threatened species/habitats will be evaluated - no chance for detailed analysis: which groups?
- Low budget of SNC for this WP and activities which are difficult and would fit for a separate project – not equal or appropriate share of funds comparing with responsibility for the activity share coordination for different animal groups (SZIU, ANCLP, INC PAS) or habitats (NFC) and share external expertise (WWF DCP)
